Proposed By-Laws

July 7, 2016 amendments to the By-Laws of the Southern Nevada Gem and Mineral Society, Inc., a Nevada Non-Profit Corporation as approved by the Board of Directors for approval of the General Membership.

Most of the changes were to correct typos and clarify meanings of the By-Laws as follows.

ARTICLE VIII. Meetings

Section 1. Add: A quorum for the Board of Directors meetings shall be 5 voting members.

Section 2. Add: A simple majority vote of the attending voting membership carries any motion.

ARTICLE IX. Membership

Section 3.

Paragraph B. to read: Family membership shall consist of a married couple, domestic partnership or parent with children under eighteen (18). Grandparents with grandchildren in attendance must obtain parental consent forms to bring them to club activities. Grandparents must have a family membership listing said grandchildren.

ARTICLE X. Officers

Section 2. President, Vice President, Secretary, Treasurer and Parliamentarian Shall be elected by a majority vote of the General Membership to a term of one (1) year and shall be eligible for three (3) consecutive years on the Board of Directors; One (1) year must pass before that member is eligible to again run for any of the above named positions. /l

Section 3. to read "Before a member can be elected to any office or Board position, they must have been a member for 24 consecutive months as of October 1st of the year of nomination."

Section 4. to read "Should an officer be unable to attend either Board Meetings or General Meetings, that officer shall notify the Board of Directors as far in advance as possible.

Section 6. Add: (For replacement procedure see Article XII, section 6, Letter K.)

ARTICLE XI. Permanent Expulsion

Section 3. The Board of Inquiry shall give a Written Notice, Via Certified Mail with Return Receipt, to appear before them, at a time and place designated, and show just cause why action should not be taken. Failure to appear or respond without just cause shall be cause for immediate expulsion.

Section 4. Expulsion Notification must be made via Certified Mail with Return Receipt.

Section 5. Any expelled member may re-apply for membership, to the Board of Directors, after a Thirty Six (36) month waiting period. New membership must be approved by a majority vote of the Board of Directors.

ARTICLE XII. Duties of Officers

Section 2. The Parliamentarian shall:

C. Bring copies of the current By-Laws of the Corporation and Roberts Rules of Order, Newly Revised, and most current edition, and to advise on Parliamentary Law to all General and Board meetings.

Section 4. The Secretary shall:

F. Bring minutes of all current meetings to be approved by the Board or General Membership as appropriate.

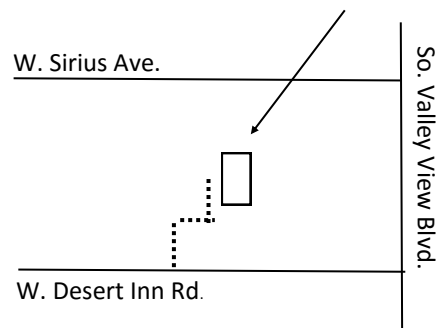

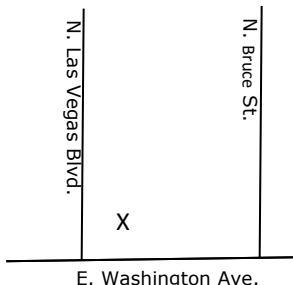

July 2nd the club was invited to a Panetarium event, hosted by our member Andrew Kerr.

The meeting this month was on July 17th. The focus was on The Ten Deadliest Rocks and Minerals. The kids learned how to recognize them and take precautions when handling them in the field or at the shop.



Several buckets of rocks were identified and then distributed to the kids for their collections.

Field Trip Fun

We love our field trips. We love collecting and just the enjoyment of being outside in Nevada. I wanted to take the time to talk about driving off road safely and some good safety tips for our members to follow.

Prepare your vehicle: always have a full tank of fuel at the start of any trip. Bring extra fuel in a safe can if necessary. Check your tires: old tires, even with good tread, can be brittle and puncture easily. All terrain tires work great. I used to have Kevlar-wrapped knobby off-road tires on the jeep but developed a very severe "death wobble" as they wore down. The problem was solved when the guys at Discount Tire recommended Falken LT265/75R16. I have gone over the roughest roads that we will travel as rock hounds and aired-down to run Dumont Dunes with those tires and never had a problem. Bottom line...go high on the ply when picking out your new tires. Tell your tire guy what you intend to be doing with your vehicle.

Buying something to take off road? 4 Wheel drive and high clearance is the way to go. High Clearance is more important than 4 wheel drive, as we always have wash outs to contend with. All wheel drive is not the same as 4 wheel drive. If you need to traverse a climb that is in the dirt, you may want to be able to go into 4 wheel low, 3rd gear, to make that climb. Talk to the 4 wheelers before you make your purchase.

Don't get left behind! When we are keeping the group together on the highways and paved roads, we want to keep a tight group. Don't lag behind and miss a turn off. If you have a problem, call the leaders with your cell phone and let them know what is going on. If the group is off-road, you need to stay together, but don't tail gate. When climbing a hill, give the guy in front of you time to reach the top (just in case he can't make it and needs to back up) before you go. If you have a problem, immediately turn on your flashers on and stop. The guy in front of you needs to stop and put on his flashers and so forth, until the entire group has stopped! You never know who might have the right tool to help with the problem. If you allow the vehicles in front of you to continue ahead, you may cause everyone behind you to lose the group. We rarely have cell service off-road. It is the responsibility of every driver to keep track of the guy behind him. If he has stopped, put your flashers on to alert the guy ahead of you, and stop and see what is going on.

Get a CB radio: If you have a CB radio, you can let everyone know what is going on. Sometimes you just need to stop to relieve yourself behind a tree. Many Rock and Gem Clubs require their members to have CB radios. They don't have to be bulky. Get one where the works are in the hand set. You can use an installed antenna or a magnetic one.

Off road tow service: Just so you know, AAA won't go off road to tow you. Bring a heavy duty tow strap and battery jump cables in your "go kit".

We have never lost anyone and we don't want it to happen in the future. Follow the field trip guidelines from our website and talked to the experienced rock-hounds about their experiences. It will assist you in being ready for a safe and fun outing.

Silver Smithing meets every Tuesday at 5 PM, with Bill Lemmon leading the class. This class is suitable for beginners, and also for intermediate to advanced students. .

Wire wrapping, beading, metal smithing, flint knapping, and silver smithing have a very modest donation of \$5.00 per session, that goes to the club. Faceting is \$5.00 an hour, the cost of faceting machine use, or a flat \$5.00 if you use your own machine. Other class donations may vary, depending on what is included in the class. ARTICLE XIII. Standing committees

Section 10. Inventory

D. Conduct an audit of the Club inventory as directed by the Board of Directors during May / June each year, by a committee appointed by the Board of Directors to include the General Shop Foreman.

Section 11. General Shop Foreman

B. Appoint duty shift supervisors.

Section 14. Field Trip Chairperson

Organize and Pre-run field trips. Pre-run to determine the condition of the roads to the location and status of the location (BLM, Forest service, Private or Claimed) if private or Claimed obtain entry permissions to site.

Delete paragraph E. Provide a map of Field Trip location and how to get there.

ARTICLE XVI. STANDING RULES

Paragraph 3. Change to: "Membership dues are due and payable January 1st of every calendar year. Renewal dues paid after January 1st, but before February 1st, shall require a \$5.00 late fee. The late fees are to ensure that the delinquent member can maintain continuous membership status. Any dues paid from February 1st forward shall be considered a new membership."

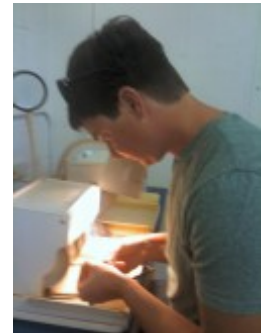
